

All candidates are required to carry along with them the following **Original Documents** on the day of the interview:

- i) Original Identity Card (ID)

- iv) Original letter of accreditation or equation for those with foreign degrees
- v) Valid Practicing License from a relevant regulatory Body (where applicable)
