# REF: BUSIA COUNTY CIVIL SOCIETY ORGANIZATIONS PROPOSAL FOR CHILDREN CARE AND PROTECTION BUDGETARY ALLOCATION FOR FY 2021/2022 BY THE COUNTY GOVERNMENT.

As partners working with Busia County Government, we recognize that The County Fiscal Strategy Paper is published in accordance with Section 117 of the Public Finance Management Act, 2012. We note that in preparing the County Fiscal Strategy, the County Treasury shall seek and take into account the views of: a) The Commission on Revenue Allocation, b) The public, c) Any interested persons or groups, and d) Any other forum that is established by legislation.

Having gone through the document and participation in public hearing forums and in reference to other child protection studies, we realize that Busia county has high incidences of child abuse and neglect, including defilement, child trafficking sexual exploitation, early marriages and physical abuse, child labour, incest and general neglect of children by parents/guardians, orphans, children living with HIV and other categories of vulnerable children. There are also children living in streets especially in the border towns of Busia and Malaba. According to the Child Protection Information Management System (CPIMS) the most reported cases of child abuse in Busia Law courts are as follows from the period of January -December 2020

According to the Child Protection baseline survey report conducted in Busia County by Joining Forces Alliance in January, 2021, 85.3% boys and 92.6% girls aged 1 to 17 years had experienced some form of abuse, unfortunately only 2.1% of these children felt adequately supported by their parents/ guardians. The findings also showed that children, parents/ care givers had very little knowledge on reporting on child abuse cases. The capacity of child protection actor and community based organizations to respond to the cases of child abuse was only at 59.1% and 37.5% respectively. The report recommend the need to:

a. Capacity building of the Child Protection Actors through strengthened Area Advisory Council(AAC)

b. Establish a Child Management Committee at Ward Levels to take lead in creating awareness on Child Protection in the community.

c. Prioritize Child Protection at all levels of planning, policy and budgeting as enriched in the constitution

d. Establish coordination framework that brings all partners under one roof with a common reporting framework for efficiency and effectiveness

Additionally, according to MOH report on adolescent pregnancies 2020, the number of teenage pregnancies presenting with pregnancy at 1<sup>st</sup> ANC a of age 10-14 and age 15-19 in Busia county in 2020 were 400 and 11442 respectively

Currently the 2018/2022 CIDP has budgetary allocations for child care and protection while the CFSP 2021/2022 does not have the same allocation. Our analysis of CBROP 2020 shows that children programme did not get the budgetary prominence required hence little achievements.
